# **1** Introduction

1.1 The following agreement covers student's use and responsibility in borrowing a laptop, IPad and 4G router (referred to as a mobile device) from University College Isle of Man (UCM). Students, and in some cases the student's Parent/Principal Carer, need to read the agreement carefully before signing and ensure they are willing to abide by all terms and conditions contained within it.

### 2 Terms & Conditions

2.1 The mobile device will never be left unattended or unsecured.

2.2 The mobile device should be treated as a valuable object and should not be used carelessly.

2.3 The mobile device must be returned at the prescribed date and time, otherwise, an overdue charge will be incurred.

2.4 Details of the loan will be recorded by UCM's borrowing systems.

2.5 The student must use a mobile device for educational purposes only.

2.6 No additional devices or software programmes may be added or uploaded.

2.7 Modifying or changing device settings is not permitted.

2.8 Personal information must not be stored on the mobile device or shared online.

2.9 Copyright of material from electronic resources is to be observed at all times.

2.10 The mobile device is the responsibility of the student and any damage incurred while in the possession of the student will be charged for, including any necessary repairs or replacement of the mobile device. For under 18-year-old students the Parent/Principal Carer will be financially liable for the repair/replacement costs.

2.11 Failure to respect these conditions will result in future loan restrictions.

2.12 Failure to comply with UCM's ICT Acceptable Use Policy will result in the Student Positive Behaviour Policy been invoked.
