### **Glossary**

**Compulsory school age** 5-16-year-old, as stated in Section 23 of the Education Act 2001.

**Department** means the Department of Education, Sport and Culture (DESC) including schools, UCM, Villa Gaiety and MSR.

**DESC** Department of Education, Sport and Culture.

**Elective Home Education** is the term used by DESC to describe parents' decisions to provide education for their children at home instead of sending them to school. This is different to home tuition provided by the Department or education provided by the Department other than at a school.

**Key Stage 4 examinations** for the purposes of this policy includes GCSE, iGCSE and GCE.

**Private candidate** for the purpose of this policy, is an individual of compulsory school age who is not enrolled at either UCM or an Isle of Man Secondary School but who is sitting a General Qualification such as GCSE, iGCSE. This includes students who are undertaking elective home education. This may on occasion also include a student who is enrolled at an Isle of Man Secondary School but is undertaking aforementioned exams at a younger age than would ordinarily be the case.

### **Summary**

### **About this policy**

This document details the Department of Education, Sport and Culture's policy on covering the cost of examinations for private candidates who are either of compulsory school age and undertaking Key Stage 4 examinations.

#### Who is this document for?

This guidance is for the leaders, staff and the Governing Bodies of all the schools maintained by DESC and the UCM.

It may also be referenced by parents and carers, pupils and the wider public for information.

#### **Key points**

This policy applies to external candidates who are both of compulsory school age, as defined by Section 23 of the Education Act 2001.

External candidates are those who are either undergoing Elective Home Education, or children who are undertaking Key Stage 4 examinations earlier than is ordinarily prescribed.

The subjects for which the cost of examinations will be covered are those outlined in Section 4 of the Education (Curriculum) Order 2011. Key Stage 4 examinations will be available for children who are of compulsory school. Private candidate examinations will take place through the existing UCM process.

For students undertaking Elective Home Education, a maximum number of subjects will be available per student, from a prescribed list taken from the Educational (Curriculum) Order 2011.

This policy does not apply to young people aged 18 and under undertaking examinations on courses provided by private training providers.

#### **Effective Date**

This document is effective from  $1^{st}$  April 2023. It will be kept under review and updated at least annually.

### **External Examinations Policy**

### **Eligibility**

Subject to the completion of the application process, this policy applies to the following candidates:

- Children and young people who are undertaking Elective Home Education who and sitting Key Stage 4 exams.
- Compulsory school aged children who are enrolled at an Isle of Man Secondary School and are being entered to sit Key Stage 4 exams at a younger age than would ordinarily be the case.
- Children under the age of 16 must be accompanied to UCM by a supervising parent or carer during examinations, who must remain on site and be available until the child is ready to leave.

### **Number of Subjects**

Under this Policy, the number of subjects available to each private candidate who is undertaking Elective Home Education is as follows:

- For Key Stage 4 level exams, a maximum of 10 separate subjects will be available to persons of compulsory school age
- For students who are enrolled at an Isle of Man Secondary School but are being entered to sit Key Stage 4 exams at a younger age, the restrictions outlined above will not apply as their subjects will be arranged through the school to which they are enrolled.

### **Subject Areas**

The subjects for which this Policy applies, as outlined by Section 4 of The Educational (Curriculum) Order 2011, are as follows:

- English
- Art and design
- Design technology
- Economics
- Geography
- History
- Manx Gaelic

- Mathematics
- Modern foreign languages
- Music
- Politics
- Physical education
- Religious education
- Science (single or dual award or 3 separate sciences

### **Application Process**

The availability of cost-covered exams is conditional on the acceptance of an application being submitted, as per the following application process.

Applications must be made to UCM. Further guidance regarding the application process can be found at <a href="https://www.ucm.ac.im/about/exams-service/">www.ucm.ac.im/about/exams-service/</a>.

#### **Additional Costs**

Only the first sitting of a relevant exam will be covered by this Policy and the Department. Should a resit be required, the cost of this will not be covered by the Department and all associated costs will be at the private candidate's own expense.

Any occurrences of non-attendance for reasons, except for medical reasons, will be treated as the first sitting and the cost of further sittings will not be covered by the Department.

Late fees will be payable at private candidates own expense.
